

THOMAS A. FULHAM WILL BE INSTALLED AS PRESIDENT SEPTEMBER 26 AT OUTDOOR CEREMONIES ON TEMPLE STREET

Thomas Anthony Fulham will be installed as president of Suffolk University on Sunday, September 26, at 2 p.m. at outdoor ceremonies to be held on Temple Street, adjoining the school.

Governor Frances W. Sargent and Mayor Kevin H. White head the list of invited guests which includes leaders from education, government and industry as well as members of Suffolk's faculty, administration and staff. Speakers will include student leaders from the colleges and law school and representatives from the faculty and alumni.

Several hundred are expected to attend the ceremonies, which will mark the first outdoor inauguration in Suffolk's 65-year history. Judge John E. Fenton, chairman of the board of trustees, will preside and install Fulham.

Highlight of the program will be an address which will be delivered by Sister Mary Vianney Fulham, president of Mt. St. Mary College, Hooksett, N.H. She is the sister of President Fulham.

Mr. Fulham has served as president of Suffolk since October 19, 1970, when he succeeded Judge Fenton, who retired after five years as president.

The Sunday program will feature a champagne reception and tour of Suffolk's expanded and renovated facilities following the inaugural exercises.

The 56-year old Fulham has been prominent in the fishing industry for nearly 20 years and is a recognized authority in the ecology field. He has been chairman of the Massachusetts Board of Natural Resources since 1954 and is U.S. Commissioner for the International Commission for Northwest Atlantic Fisheries, representing 15 nations. The inaugural ceremonies will be opened by Judge Fenton, who will introduce Superior Court Judge Frank J. Donahue, dean of the Massachusetts jurists, and former long-time treasurer of Suffolk University and presently a trustee. Judge Donahue will bring welcoming remarks.

The greetings of the city will be delivered by Mayor White and the Commonwealth's remarks will be brought by Lt. Governor Donald Dwight. Governor Sargent will be unable to attend because of a personal commitment.

Other speakers will include Donald W. Goodrich, retired dean and vice president of Suffolk University, who will speak on behalf of the faculty, Neal D. Hannon, president of the Suffolk General Alumni Association, Joseph B. Shanahan, president of the Suffolk Student Government Association, and John C. Deliso, president of the Suffolk Student Bar Association.

President Fulham's response will be made following the address by Sister Mary Vianney Fulham.

The invocation will be delivered by the Reverend Harold G. Ross, Jr., pastor of St. John's Baptist Church, Woburn, while the Reverend Monsignor Russell H. Davis of St. Paul Church, Wellesley, will give the benediction.

Music for the occasion will be supplied by members of the Boston Fire Department Band.

S.U. BUILDINGS NAMED FOR ARCHERS AND JUDGE DONAHUE

The Suffolk University Board of Trustees, in an action taken at their September 8 meeting, voted to name two university buildings after Gleason L. and Hiram J. Archer and Judge Frank J. Donahue, former treasurer of Suffolk and life-time trustee.

The Derne Street building, commonly referred to as the "old building," will be named The Archer Building in memory of Gleason L. Archer, founder of Suffolk, and his brother, Hiram, late clerk of the corporation, professor and life trustee.

The Temple Street structure, or "new building," will be named The Frank J. Donahue Building in honor of Judge Donahue, the 90-year old Massachusetts Superior Court jurist, who has given so much of himself to the law school and colleges since his graduation from the law school 50 years ago.

President Fulham noted that "the board of trustees found it most fitting to recognize the significant contributions made by these men to Suffolk's history. The tireless dedication and devotion to Suffolk University by Gleason and Hiram Archer and Judge Frank Donahue will always be remembered by students, alumni and all of Suffolk's family."

The board also voted to identify the building on Cambridge Street and Ridgeway Lane, now used for classrooms and student activity offices, as the Ridgeway Building.

PROFESSOR FIORILLO VOTED HONORARY DEGREE

Professor D. Donald Fiorillo, chairman of the Suffolk Sociology Department and a member of the faculty for a quarter of a century, has been voted an honorary degree by the Board of Trustees. The board took the action at its September 8 meeting.

Professor Fiorillo is scheduled to receive the honorary degree of doctor of humanities at the Sunday commencement at which Charles H.W. Foster, State secretary for environmental affairs, will speak and receive the honorary degree of doctor of public administration.

President Fulham noted that "it is with great pride that I am able to confer an honorary degree on Professor Don Fiorillo. He has given an entire career to Suffolk and has been a true pioneer in the development of many programs which have contributed to making this university the progressive institution it is today."

Fiorillo, 47, joined Suffolk's faculty following graduation from Clark University (AB 1945). He earned his master of arts degree at Boston College in 1949 and did doctoral study at Boston University.

During his long tenure at Suffolk, he has served the university in many capacities. He was an assistant dean in charge of activities in 1947. Student clubs he founded included the Sociology Club, the Veterans Club and the Varsity Club.

It was Fiorillo who established recognition awards for student academic and athletic achievement. He also served as basketball coach one season.

He founded the Suffolk University Internship Training Program for Sociology majors back in 1949, founded the Suffolk University Forum, featuring noted lecturers, and the Suffolk University Labor-Management Institute.

He is director of the Suffolk University Social Welfare Program, founder of the Suffolk Crime and Delinquency Studies Program, and founder of Suffolk's Urban Studies Program.

Most recently, Prof. Fiorillo was coordinator and director of a highly successful summer institute on drugs sponsored jointly by Suffolk's Sociology Department, the Attorney General's Office and the Massachusetts Department of Education.

He makes his home in Shrewsbury with his wife, Pauline, a daughter, Paula, 19, and son, Donald, 17.

SEPTEMBER ... A BUSY MONTH AT S.U.

Thirty days hath September, but it's such a busy month at Suffolk, we could use a few more days on the calendar.

A commencement, an inauguration, orientation, registration, a re-accreditation meeting. These are just some of the things keeping faculty and staffers on the go.

All those new faces registering in the colleges reflect an increase in admissions, certainly a healthy sign. At orientation programs, approximately 340 new freshmen were welcomed as were 325 transfers at separate ceremonies.

"This represents an increase in freshmen of approximately 40 students from last year," said Bill Coughlin, director of admissions. "Transfers are up about 10 from last year. In light of decreasing admissions at many colleges, this is very heartening to us."

In the law school, about 700 new first year students were greeted at orientation programs for day and evening divisions with the total about evenly divided between evening and day students. They were welcomed by President Fulham, Dean Simpson, faculty members and student officers, and a reception followed both orientation sessions.

ABOUT 130 DEGREES WILL BE CONFERRED at Sunday's September commencement. Degrees will be awarded in the colleges of liberal arts, business administration and journalism. S.U. is happy to welcome Charles H.W. Foster, the Commonwealth's new secretary of environmental affairs, as commencement speaker. Marshal will be John J. McCarthy (BSBA, 1949).

RE-ACCREDITATION - In preparation for the upcoming re-acceeditation visit by the New England Association of Colleges and Secondary Schools, President Fulham has called a joint meeting of administrators, members of the long range planning committee, department chairmen, and chairmen of study committees. The meeting will be held in Room 517 on Tuesday, September 28 from 4 to 5 p.m.

A reception in the President's Conference Room from 5 to 6 p.m. will follow the meeting, and there will be dinner and discussion from 6 to 8 p.m. in the Faculty Dining Room. Dean Joe Strain is chairman of the planning committee.

AND FINALLY, to close out that 30th day of the month, there is the opening lecture of the fall series, "Perspectives-Consumer Business Relations," being sponsored by Suffolk's College of Business Administration and the Better Business Bureau of Eastern Massachusetts.

Kicking off the four-part fall series will be Walker Sanbach, executive director of Consumers Union and publisher of Consumer Reports. All of the sessions will be held in the Suffolk University Auditorium at 2 p.m. Tickets are available at a cost of \$6 for all four lectures. Other speakers will be Atty. General Robert H. Quinn (October 19), Miles W. Kirkpatrick, chairman of the Federal Trade Commission, (November 4) and Elisha Gray III, chairman of the board of Whirlpool Corporation (November 30).
