UNIVERSITY AIMS TO DEVELOP HUB MARINE CONSORTIUM

A one-day workshop aimed at developing a marine education consortium among Boston area colleges and universities has been scheduled for Dec. 1 at M.I.T.'s Endicott House in Dedham.

Suffolk University, along with the MIT Sea Grant Office, the New England Aquarium and the Massachusetts Marine Educators have combined forces for the initial meeting, according to Dr. Arthur J. West of the Biology Department. Some 100 area institutions have been invited to send representatives.

West, who is the workshop coordinator, is hopeful that a cooperative program can be established. Papers from marine education experts will be distributed at the workshop.

Among the topics to be discussed will be the need for an inter-institutional base for cooperation in marine education; existing models of inter-institutional educational programming and resources presently available; and development and implementation of cooperative multi-disciplinary marine education programs.

Dr. West said the purpose of the workshop is to develop an undergraduate model for colleges and universities around Boston.

"We hope to build upon another earlier beneficial experience the university had as a member of the New Hampshire Marine Sciences Consortium involving 10 New England institutions and utilizing the facilities of Suffolk's Robert S. Friedman Laboratory at Cobscook Bay, Maine," Dr. West said.

"There are limited capabilities in marine education," he noted. "By sharing or pooling resources, it could be beneficial to many schools." He pointed out that Suffolk, for example, does not have a geology or oceanography program. "If we were in a consortium our resource potential might be expanded," West said.

LYNCH TO RETIRE

John W. Lynch, law librarian since April, 1967, will retire from that position in December.

"I've had a very fond association with Suffolk for 10 years," Lynch commented upon his impending retirement. "I've made many friends among both law and college faculty and the administration and will have some fine memories."

Lynch, 65, was the first librarian for the Law School (prior to his arrival duties were combined with the college librarian). During his tenure, the law library grew from 30,000 volumes to 90,000 and facilities were greatly expanded.

A judge advocate in the U.S. Army for nearly 20 years, serving throughout the world, Lynch also has practiced ~~private~~ law and was librarian at Middlesex County Law Library before coming to Suffolk.

Lynch has lived in Charlestown for many years and walks to school every day. He and his wife, Frances, have bought a home in Isle of Palms, S.C. They'll move there after the first of the year. . .

BRODY, WIFE CO-AUTHOR BOOK

Law Professor Al Brody is a non-smoker. His wife, Betty, smoked regularly until numerous household debates caused them both to consider the legal rights of non-smokers.

The result: A paperback book written by the Brodys and published by Avon Books, entitled *The Legal Rights of Non-Smokers*.

Brody, who recently spoke at the *Boston Globe's* Book Fair, explained, "In most arguments against smoking, the focus has largely been on health reasons, but the legal question is equally important. We consider not only health dangers, but economic problems as well and statutes and existing and potential judicial remedies."

"We think we bring out in the open a lot of things people are thinking but are not articulating. While the book is legal, it is written for a lay audience."

Betty Brody, who has since quit smoking, is also a lawyer and a 1971 Suffolk Law School graduate. . .

ADMINISTRATIVE SALARY EVALUATIONS WILL BEGIN OCT. 31

The Evaluation Committee selected for the wage/salary program for members of the administration will begin meetings on Oct. 31, Personnel Officer Judy Minardi has announced.

The program will be conducted by Hay Associates, one of the 10 largest consulting firms in the country, and is designed to establish an equitable salary structure within the administration. Hay previously conducted a similar study of clerical and supportive staff positions.

Selected for the evaluation committee were Dean Michael R. Ronayne of Liberal Arts; Dean Richard L. McDowell of the Business School; Dean David J. Sargent of the Law School; William F. Coughlin, director of college admissions; Ellen B. Peterson, director of alumni activities; Paul Ryan, business manager; and Jane Morris, law librarian.

The committee is expected to hold weekly meetings and hopes to complete its evaluations by the first week of December. It will be directed by Joan Varga of Hay Associates. Personnel Officer Minardi will join the meetings for informational purposes.

Based on the job evaluations and a salary survey of comparable positions in the outside market, Hay Associates will make recommendations to the University for salary ranges, implementation of the new program and methods of handling salary increases. The recommendations will go to the Board of Trustees by February.

All 60 administrative positions were examined and defined by a job analysis committee made up of Hay representatives and the following members of the University administration: College Placement Director James G. Woods; University Development Director Frank L. Whitson; College Librarian Edmund G. Hamann; Asst. Law Placement Director Elizabeth K. McCombs; College Admissions Counselor Martha H. Barrett; Law Admissions Asst. Director Marjorie A. Cellar and Minardi.
