## SBA Dinner Draws 400

Judge Frank J. Donahue received the annual Dean Frederick A. McDermott award for 1974 at the Law Day dinner last month at the Chateau de Ville in Framingham. More than 400 persons cheered the 92 year old jurist as he received the honor for his long service to Suffolk.

A Life Member of the Board of Trustees and former Treasurer at Suffolk, Judge Donahue retired last fall as Senior Justice of the Mass. Superior Court, where he served since 1932. He holds two honorary degrees from Suffolk, and in 1968 the Diocese of Worcester awarded him the St. Thomas More Society Silver Medal. He graduated from Suffolk Law School in 1921, and prior to serving on

the bench he was the state's youngest Secretary of the Commonwealth and later Chairman of the State Industrial Accident Board.

Main speaker at the dinner was Henry B. Rothblatt, one of the counsel of the Watergate defendants, and alumnus Richard A. Voke, AB70, President of the Student Bar Association, which sponsored the event, was Toastmaster. The McDermott Award, established in 1964 in memory of our late Law School dean, is given each year at the Law Day dinner.

Alumnus Catherine T. Judge, LLB57, LLM60, received the Distinguished Professor Award, which is presented annually by the Student Bar Association. Prof. Judge, formerly the Law School Registrar, is Suffolk's first woman law professor, and has served on the faculty for eight years.

Associate Dean John E. Fenton, Jr. of the Law School has been appointed an Associate Justice of the Mass. Land Court by Governor Francis Sargent.

Dean Fenton, a member of the Law faculty since 1957, will now join the same court where his father, Judge John

E. Fenton, Chairman of the Board of Trustees, served for 28 years.

A cum laude graduate of Holy Cross, Dean Fenton received his Juris Doctor degree from Boston College Law School, and his master's in law degree from Harvard Law School. *Alumni News* congratulates Dean Fenton.

## College Enrollment Outlook Optimistic

Suffolk's college enrollment figures remain stable, despite statistics to the contrary in other area colleges and universities. As of mid-April we were up 11 deposits over this time last year, although applications were down by 40.

These figures indicate that college departments enrollment will remain the same for next year, according to admissions officers William Coughlin and Edward Saunders. They told *ALUMNI NEWS* that they are optimistic the following enrollment figures will be realized: 325 incoming freshmen; 300 transfer students; and 100 graduate students.

Currently the University of Mass., Boston is down 30% in applications, and another state school, Mass. Bay Community College is down nearly 10%. Among private schools in the area, Tufts University is down 1500 applications from their anticipated figures.

# Dean of Radio Sportscasters Retires at 76

Manuel Marget graduated from Suffolk Law School in 1918 at the age of 20 and immediately joined the U.S. Navy. After his discharge he decided to pass up a law career, and "go commercial." For the next five years he traveled over most of the United States, as a salesman for a Boston leather house.

In 1924 he settled in St. Louis and worked in various enterprises for five years, until he decided to move again, this time to Fargo, North Dakota, "where I really found my niche," he told the ALUMNI NEWS.

Here he began one of the most illustrious careers in radio broadcasting history. In nearly 45 years of sports broadcasting, Marget aired almost 6,000 events. Basketball leads the list, with 2,214 games, and baseball, with 1,718 games, is next. He broadcast 653 football contests and 175 softball games, in addition to numerous bowling, boxing, hockey, track, wrestling and other sports events.

Most of his radio career was spent in Fargo, and Moorhead, Minnesota, and a year and a half in Kansas City. Among his many thrills, he says, was the broadcasting of the Minnesota State High School Basketball Tournament for the past 36 years. Since his recent retirement he attended the tournament last month for the first time as a spectator.

These games are played in Minneapolis and Saint Paul, and when the station announcer from Fargo was taken ill at the recent tournament, Marget was called on to broadcast the last three games.

Describing himself now as "happily retired," Marget remarried last summer. He has moved back to St. Louis, and now travels extensively, and "we are enjoying the new life together." His first wife, whom he married in 1929, died in 1960, and his only child, a son, died in 1970.

When Marget was a student at Suffolk Law School, he attended classes in the school's first permanent home, at 45 Mt. Vernon Street. He wrote the NEWS:

"I am sure Suffolk has changed from the hectic days in which I attended, and although I did not go into law practice, my schooling was very helpful in business on many occasions."

Concerning his career, Manny Marget declares, "I believe I was the oldest active play-by-play announcer in the business when I retired."

ALUMNI NEWS agrees, and we extend heartiest congratulations to our dean of broadcasting and outstanding pioneer alumnus.

# Alumna Likes Travel

When the Suffolk jet leaves Boston for Rio de Janeiro for the alumni holiday trip next month, there will be at least one happy alumna following her pleasant avocation — travel. Dorothea Machado has already been to Europe four times, and in 1961 she took a four-month trip on a freighter.

Dorothea earned her Bachelor of Arts in 1949, and soon afterward she went to work for the Mass. Department of Public Health in Boston. Two years later she was working in publicity for the McGraw-Hill Publishing Co. in New York City.

After two years there, she returned to her hometown, New Bedford, and worked as Secretary to the Publisher of the Standard Times, Basil Brewer. In 1955 she moved to California for a position with the Hughes Aircraft Co., engaged in aerospace activity.

She was the first woman in her division to receive Top Secret clearance, and worked on such government programs as Phoenix and SARCALM. Dorothea remained with the Hughes firm until late 1970, when she received news of her mother's terminal illness, and returned to the east coast.

After her mother's death in 1971, Dorothea chose to remain in this area to be closer to her family, and has been working since then for the First National Bank of New Bedford.

In addition to traveling and meeting the public, Dorothea is also interested in writing. She has returned several times to Saint Michael, in the Azores, because of her parent's heritage, and would like to write about the Portuguese people.
