#### 10 YEARS AS LAW DEAN

#### Fellowship Established For Sargent; He'll Be Honored at Oct. 20 Dinner

David J. Sargent, dean of Suffolk University Law School, will be honored at a testimonial dinner Oct. 20 at the Copley Plaza commemorating his 10 years as dean of the Law School.

To mark his decade of outstanding leadership, a Committee of Alumni and Friends of Dean Sargent is establishing the David J. Sargent Fellowship Fund as a lasting tribute to Sargent for his contributions to the quality of legal education at Suffolk University Law School and throughout the nation.

Sargent Fellows will be selected for distinguished academic performance and demonstrated need and will represent the highest form of academic recognition in the law school. Proceeds from the dinner will be used to establish the Sargent Fellowship Fund to finance those selected Fellows.

Sargent has been associated with Suffolk University Law School for more than 30 years. He is a 1954 graduate of Suffolk Law School, graduating first in his class and is holder of an honorary doctor of laws degree awarded in 1978. He was appointed dean in July of 1973 to succeed the retiring Donald R. Simpson. Prior to that, he had been a member of the faculty for 16 years.

The Law School has enjoyed a remarkable era of progress under Sargent, developing from a regional law school with limited recruitment to an institution that now attracts students from more than 400 colleges and universities throughout the country.

Co-chairman for the dinner are Atty. Paul T. Sugarman of the Boston law firm of Sugarman and Sugarman and Atty. Harold Widett, J.D.'32, of Widett, Slater & Goldman, P.C. A 6 p.m. reception will precede the 7 o'clock dinner. Tickets are \$125 per person and are being handled through the Office of Institutional Advancement, 11 Beacon St., Ext. 444.

As a tribute to Dean Sargent, the Suffolk Law Review, at its annual fall dinner Oct. 1 at the Marriott Long Wharf Hotel, announced it would dedicate the first issue of Vol. XVIII to Sargent for his 10 years of Law School leadership and support of the Law Review.

Enrollment: Last year the full-time freshmen enrollment and overall FTE enrollment was the highest in the hiscrease over 1981 and 54 percent higher than in 1980. Preliminary enrollment figures for 1983 indicate that our entering freshmen enrollment is higher than 1981 but not as high as last year. men and transfer students is the second highest in history. Overall, the enrollment is about the same as last year at this time.

Reaccreditation: The report of the visiting team representing the American Bar Association and the Association of American Law Schools has many complimentary observations about the changes which have taken place in the Law School since their last inspection visit seven years ago. The visiting team represent-ter for the draft in order to receive ing the New England Association of Schools and Colleges was very positive in its evaluation of Suffolk University last year.

Renovation: There have been major renovations in the Archer and Donahue buildings during the summer as well as work in Fenton and Sawyer in accordance with the recommendations of a facilities audit conducted by our architects. It is the University's objective to bring its older buildings up to the standard set in the Sawyer Building over the course of the next few years. Last spring we dedicated the new faculty lounge in the Archer Building.

#### Title III of the Higher Education Act:

The University recently was informed that it will receive an increase in its grant under Title III of the Higher Educa tion Act, the Strengthening Developing Institutions Program for fiscal year, 1983-84. The new award is expected to amount to approximately \$430,000. These funds support activities designed to improve services for our undergraduate students, strengthen University administration and further develop the abilities of faculty and staff.

> Student Aid Policy: There is a federal requirement that eligible students regisfederal student aid. The Board of Trustees, at its September 14, 1983 meeting, adopted the following policy concerning the use of the University's financial aid "No Suffolk University student who has otherwise qualified for student financial aid shall be denied institution al support because of his failure to register for the draft or to sign the draft registration compliance form. The Univer sity will not, however, provide institutional support to replace federal support withdrawn from the student because of his failure to comply with the law."

### Bank of New England Grant Helps Establish 'Project Excel'

A \$5000 grant from the Bank of New England has helped the University establish a "Project Excel" program for talented Greater Boston High sophomores and juniors.

The program, which will be under the direction of Dr. Glen Lewandowski, professor of education, is designed to enhance the traditional high school curriculum and provide a bridge into higher education for gifted 10th and 11th graders.

"It is also a response to the call for excellence as stated in the recent report of the President's Commission on Excellence in Education," President Daniel H. Perlman said in announcing the program. Perlman added that the University has "a commitment to assist in the revitalization of Metropolitan Boston's educational system and to expand the opportunity for intellectual growth available to talented young people in the area."

Under the plan, 90 students from area high schools will be selected for the first phase of the program, which will start in February. Students will meet at Suffolk each Wednesday from 3 to 5 p.m.

Lewandowski said that there will be no tests, grades or credits. "We want to encourage analysis of conflicting information and the integration of scientific, aesthetic and moral concepts," he noted. Suffolk faculty and guest lecturers will be utilized.

"The Bank of New England, in helping establish "Project Excel," has proved that it has a deep interest in improving the education opportunities for students in the Greater Boston area," President Perlman said.

"Project Excel" stems from a proposal put together by Presidential Executive Assistant Diane Rudnick and Lewandowski and discussions with bank officials Tim Kilduff and Bernie Fulp.

### Ex-Governor King Named Executive in Residence

Former Gov. Edward J. King has been appointed to the position of executive in residence at the School of Management, Dean Richard L. McDowell has announced.

Under King's appointment, he will be on campus twice each semester for talks with scheduled classes of graduate and undergraduate students as well as faculty, alumni and other guests.

"We are pleased to have a man of Gov. King's caliber as an executive in residence," McDowell said. "His knowledge and experience will blend effectively with the business and public dimensions of the school's programs. Appointment of a man of King's stature will also create a basis for future appointments at the highest level of public and business executive management."

### Retired Librarian Sullivan and Late Coach Law Honored

The Heritage Committee presented medallions and citations to retired Library Director Richard J. Sullivan and the widow of athletic director Charles Law at Founder's Day ceremonies Sept. 19.

Sullivan came up from his home in Aiken, South Carolina for the ceremony, accompanied by his wife, Mary.

Mrs. Phyllis Law, widow of long-time athletic director and head basketball coach Charlie Law, accepted the medallion for the late coach, who died in 1981.

Heritage Committee Chairman David L. Robbins made the presentations as part of the Founder's Day program, which also included the official unveiling of Campaign for Excellence plaques in the Sawyer and Donahue buildings.

## University Names Dr. Jordan to Full-Time Minority Post

Dr. Carolyne Lamar Jordan of Lexington has been appointed assistant to the president and director of minority affairs, President Perlman has announced.

Long a part-time position, the job of director of minority affairs coupled with assistant to the president was established earlier in the year by the Board of Trustees upon recommendation of an affirmative action task force and Perlman.

Jordan previously was associate professor of psychology and music at Salem State College. # United Way Campaign is Underway at Suffolk

The 1983 United Way campaign at Suffolk University kicked off with a luncheon Oct. 3 at which a goal of \$10,000 was set for the drive.

President Perlman addressed a group of University team leaders and urged a 15 percent increase over last year's record setting total of \$8794. This percentage is consistent with the increase called for in the overall United Way goal of \$32 million.

Dr. Perlman, who is chairman of the Education Division for the United Way, welcomed Jack Lucey, loaned executive from United Way, and guest speaker Susan Piver from the Samaritans, a United Way agency.

Also addressing the group was Louis B. Connelly, director of public relations and United Way chairman at Suffolk.

Connelly announced that this year the University is offering an added incentive to help boost the University over its 1983 goal. A Suffolk University captain's chair, donated through the courtesy of the Campus Bookstore, will be presented in a drawing to one lucky donor at the close of the campaign.

To be eligible for the chair, a donor must contribute a minimum of \$52, or a dollar a week for the year.

University faculty and staff are urged to utilize the payroll deduction plan.

### University Receives \$125,000 Hayden Grant

The University has been notified that it has received a grant in the amount of \$125,000 from the Charles Hayden Foundation towards renovation of the Archer, Fenton, Donahue and 56 Temple St. Buildings.

Refurbishment has been underway on these buildings following an audit by architectural consultants Knight, Bagge and Anderson, Inc. of the condition of all Suffolk properties.

In addition to the Hayden grant, the University received a grant of \$10,000 from the Schrafft Charitable Trust for similar renovation of the older buildings.

The University has received financial assistance awards from the U.S. Department of Energy. The awards are for projects in the Fenton Building and the Archer/Donahue complex. An award of \$1750 was made for a technical assistance energy audit in the Fenton Building and will be matched on a 50/50 basis by the University.

Based on an energy audit conducted prior to submission of the proposal, the Department of Energy awarded the University \$80,000 to implement recommended energy conservation measures. This award will also be matched by University funds.
