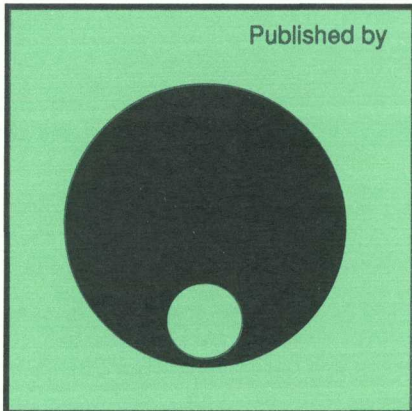

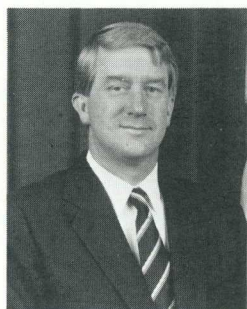

### Gov. Weld, Speaker Foley Will Give Commencement Addresses

Gov. William F. Weld and U.S. House Speaker Thomas S. Foley will share the commencement speaker spotlight at the Wang Center on Sunday, May 31 when the exercises of the College of Liberal Arts and Sciences and School of Management and Suffolk Law School are held.

Weld will address the CLAS and SOM graduates at 2:30 p.m. exercises while Foley will be the keynote speaker at the 10 a.m. exercises of Suffolk Law School.

President David J. Sargent will confer degrees on 500 graduates of SOM and CLAS and 503 juris doctor candidates from the Law School.

Sargent will confer an honorary doctor of public administration degree on Speaker Foley. Later in the day, he will award an honorary doctor of laws degree to Gov. Weld.

Honorary degrees will also be awarded to the following: Washington, D.C. Circuit Judge **Patricia M. Wald**, doctor of laws; **Harold Hestnes**, senior partner in the law firm of Hale and Dorr, doctor of laws; Chief Justice of the Superior Court **Robert L. Steadman**, doctor of laws; Judge **David S. Nelson**, U.S. District Court Judge for the Massachusetts District, doctor of laws; **Raymond Shamie**, president of Shamie Management Corp. and Massachusetts civic leader, doctor of humane letters; **Marva N. Collins**, educator and founder of the Westside Preparatory School in Chicago, doctor of humane letters; and **Nader F. Darehshori**, chairman and chief executive officer of Houghton Mifflin, doctor of commercial science.

Weld, who served as U.S. attorney for Massachusetts for five years and won convictions in 109 of 111 political corruption cases, was elected governor in November of 1990.

Foley has served as U.S. House speaker since 1989 and prior to that was House majority leader. He represents the State of Washington.

Marshals for the exercises will be Robert P. Edson, BSB '67, MBA '72, for the Colleges and Justice Charlotte A. Perretta, JD '67, of the Mass. Appeals Court, for the Law School.

Commencement, held at the Hynes Memorial Convention Center a year ago, was scheduled for that location, but it was moved to the Wang as a more convenient scheduling for graduates in all divisions. ○

### University Hopes for Fall 1993 Opening at Women's City Club

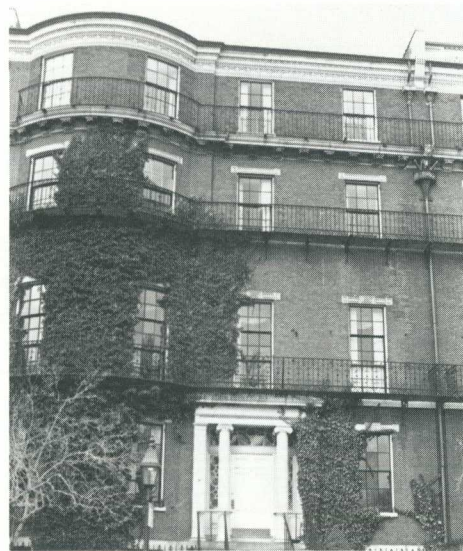
The University, which acquired the historic Women's City Club of Boston at 40 Beacon St. on March 25 at a public auction, is aiming for a Fall, 1993 opening of the facility.

Suffolk President David J. Sargent is confident that zoning variances and any neighborhood objections can be worked out to allow the University to consummate the auction bid of \$2.6 million for the 18,000 square feet of property overlooking Boston Common.

Following renovation, the University plans to utilize the building as a University club and for some of its administrative offices now housed at One Beacon St. Suffolk will also make the facility available to the Women's City Club for its activities and to other civic and community organizations.

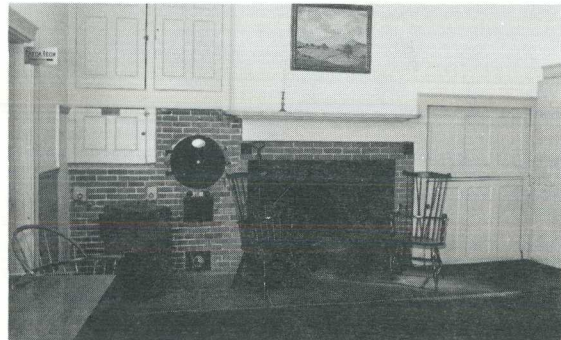
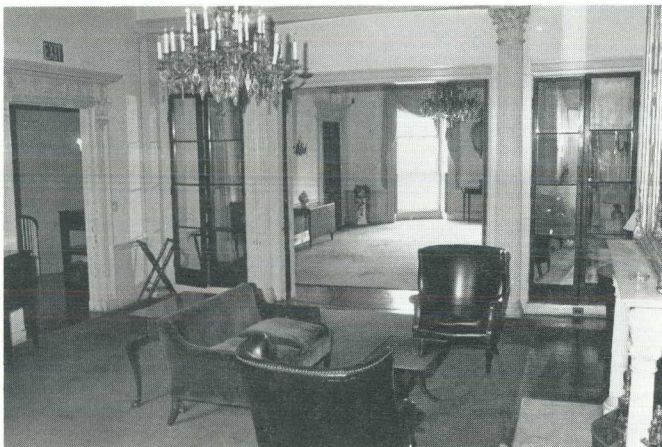
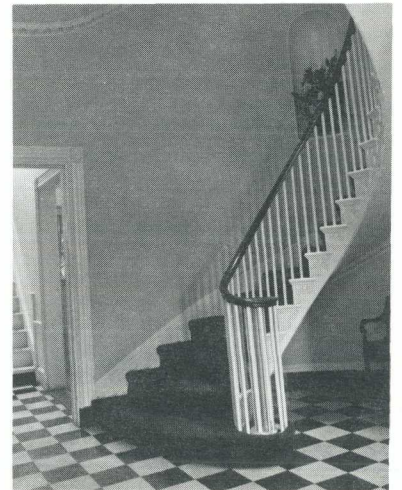
Sargent said that the interior will be restored in keeping with its original architectural appearance and said the school is still hoping for a Fall of 1993 opening date.

## Law Review Marks 25th Anniversary

Suffolk University Law School marked the 25th anniversary of its law student publication, the Suffolk University Law Review, with a gala reception at the Parker House April 21 with more than 200 guests in attendance.

President David J. Sargent and Law Dean Paul R. Sugarman addressed and welcomed the guests, most of them past members of the Law Review.

Also addressing the gathering were the only two faculty advisers in the review's history, Judge John E. Fenton, Jr., chief administrative justice of the Commonwealth's courts, and the first adviser, and Law Prof. Alexander Cella, who has been the adviser for the past 17 years. Among those on hand was Law Prof. Bernard M. Ortwein who edited Volume VI of the Law Review.

Fenton, former associate dean of the Law School before being appointed to the bench, and still an adjunct law professor, noted that he was "proud to be there at the beginning to help sow the

seeds. The Suffolk Law Review is a first class publication which has made a major contribution to both legal education and legal scholarship."

Cella noted, "I have had a unique opportunity to observe first hand the growth and development of the Law Review. I think it's fair to say that during that period of time the Law Review has become an increasingly significant source of legal knowledge and informed scholarly opinion."

The guest list included Gerald A. McDonough, editor-in-chief of Volume XXV, and this year's editor-in-chief Robert F. Fitzpatrick, Jr. Suffolk trustees Vincent A. Fulmer, Robert B. Crowe, Dorothy A. Caprera and Richard J. Leon were also among the guests at the reception.

The Law Review publishes four times a year. Its editors and staff are chosen from the second-year day classes and the third and fourth year evening classes. It has some 1300 subscribers representing nearly every state in the nation. ○

## S.U. Marketing Team in College World Series

An eight-member team of Suffolk University marketing students took first place honors in the New England District's Annual College World Series of Advertising held at the University of Hartford.

The competition, sponsored by the American Advertising Federation, involves some 150 colleges competing in 15 districts across the country.

Faculty adviser Joseph P. Vaccaro, associate professor of marketing, said that the Suffolk team will compete with 14 other regional winners June 13 in Portland, Oregon.

"This competition provides undergraduate marketing students with a realistic problem that can be solved through team effort, knowledge and creativity," explained Vaccaro.

In this year's program, the client is VISA USA. The assignment is to develop a comprehensive advertising and sales promotion plan to establish Visa as the primary general purpose credit card of choice for four year college students in the United States.

Competing on the Suffolk team are Christopher R. Agostino of Billerica, Elaine C. Deniso of Medford, Kristen Dunlap of Hanson, Christine Ferrara of Quincy, Susanne Joyce of Medford, Kenneth McLaughlin of Wollaston, Mary Ann Penta Cutler of Malden and Lisa Wentzell of Newton.

At the April 11 competition in Hartford, the Suffolk team bested rivals University of Hartford, Quinnipiac College and Northeastern University. ○

**FRANCES BURKE**, Public Management - The American Society for Public Administration and the National Association of Schools of Public Affairs and Administration has jointly presented her with the 1992 Charles H. Levine Memorial Award. She received the honor in Chicago at the national meeting. According to Executive Director John P. Thomas, the award goes to a faculty member who has demonstrated excellence in three major areas of the field - teaching, research and service to the wider community. It's based on long time contributions to literature, including governmental and other publications.

**PAUL R. KORN**, Counseling Center - He presented workshops on "Handling Battle Fatigue as We Fight Racism on Campus" at two conferences and three colleges. They were given at the American College Personnel Association annual conference in San Francisco; the New England Association of Educational Opportunity Program Personnel confab in Plymouth, and at Lesley College, Manhattanville College and Colby College.

**SUSAN THAYER**, Ballotti Learning Center - She was the coordinating presenter for a session called "Striving for Excellence" at the American College Personnel Association conference. ## Reporting a Work-Related Injury or Illness

In the event of a work-related injury or illness you should:

1. Obtain medical attention. Medical care may be rendered by the University Health Services, a family physician, an emergency care facility, an out patient care facility or a health maintenance organization. The medical provider must be informed that this is a work related injury or illness.
2. Report the injury to your supervisor.
3. Inform the Human Resources Office at extension 8415 within 24 hours of the injury or illness. ○

## Health and Dental Insurance Continuation

If your son or daughter is graduating this Spring from college, graduate school or high school, congratulations! But before all the celebrating starts you may want to take time to check the age limitations for dependent children covered under your health or dental plans. HCHP and Hancock Preferred cover children who are full-time students to age 25, otherwise to age 19. Delta covers children to age 19.

Your child may continue health and dental insurance through Suffolk University's group plans but on an individual basis through a process called COBRA. To do this your child completes an enrollment form for the plan and pays to the University each month the total cost of the coverage plus an administrative fee.

## Smoking Policy

On July 1, smoking will be prohibited throughout University facilities.

Creating a smoke-free environment is not intended as a judgment on those who choose to smoke but rather it allows those who choose not to, to breathe freely. Smokers may continue to smoke outside or they may choose to quit. The University will assist smokers who wish to quit by offering smoking cessation courses throughout the year.

The University is requiring smokers to alter their behavior in consideration of the health of non-smokers. Many proclaim this as an invasion of their rights. C. Everett Koop, MD, the former Surgeon General of the United States, put it best, "The right of smokers to smoke ends where their behavior affects the health and well-being of others...." The decision to prohibit smoking was not an easy one to make: popular for some; unpopular for others; but controversial at the very least. Credit must be given to the Administrative Council who based their decision to provide a smoke free environment on what they believe to be fair and proper for the health of this educational community; not on any law requiring such a policy.

The above is an excerpt taken from a recent letter to the Editor of *Dicta* sent from the Smoking Policy and Education Committee. ○

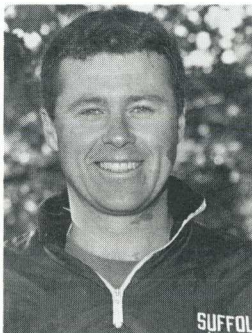
## Suffolk Nine Qualifies Again for ECAC Tournament in Connecticut

For the fifth time in the past eight years, a Suffolk University baseball team qualified for the Eastern College Athletic Conference post season tournament. And this year's 21 wins were the most in the school's history.

The 1992 Rams, under veteran Coach Joe Walsh, were one of eight Division III teams selected to play at Trinity College May 8-9. They lost to Amherst 11-1 in the opening round.

Walsh, who just completed his 11th season as Rams head coach, directed this year's team to a 21-12 record, including a 10-game winning streak at one point in the season. One of New England's most

successful coaches, the 37-year old Dorchester native has compiled a record of 162 wins and 126 losses since taking over for former Red Sox Pitcher Jim Willoughby in 1981.

"I was very pleased by the effort that this year's team put forth," said Walsh. "It was not one of my stronger teams in terms of hitting or pitching but it was a more balanced team, combining hitting, pitching and defense. I guess you'd say it was an overachieving team."

"Four of this year's squad never played high school baseball but got a chance here and developed quite a bit," Walsh pointed out.

Walsh had particular praise for sophomore catcher Tim Murray of Billerica, who led the team in batting with a .385 mark and threw out 18 runners attempting to steal. "Tim ranks with all the good catchers we've ever had."

The Coach also noted the contribution of Bentley transfer Mike Hinajosa (.339) of Revere, who hit nine homeruns

(two behind all-time Rams leader Gary Donovan) and stole 25 bases in 27 attempts.

Murray made the All New England Division III second team while Hinejosa was selected for the third team.

Another standout was Rob Zeytoonian, all the way from Weatherford, Oklahoma, who lives with a relative in Greater Boston. He batted .325 and was a valuable infielder.

In his 11 years of Suffolk coaching, Walsh has had only two losing seasons. Last year's team was 14-14.

"I guess my top team would be the 1985 team that won 20 games and lost seven and had guys like Joe Clancy, Mike Turilli, Larry Chabre and Johnny Lordan leading the way," Walsh recalled.

The 1992 Rams started slowly, dropping four of their first six games in Florida and losing three up here before going on a 10-game winning binge. The victories included a doubleheader sweep of tournament entrant Framingham State, a 10-1 win over Salem State, another tournament entry, and triumphs over Bentley and Bryant. ○

### Flexible Leave Plan

The University is also offering the Flexible Leave Plan for the summer months (June 1 - August 21.) This unpaid leave is available for the summer only. People on Flexible Leave will not be paid during the period of the leave, but their full benefits will be maintained.

The unpaid Flexible Leave may be take several forms. **Full Weeks Off** - employees may take a number of unpaid weeks off during the summer. Time off may also be coupled with paid vacation to extend a period of time off. **Full Days Off** - Employees may take a defined number of unpaid full days off per week. This leave may be combined with the 4-day work week schedule. **Reduction in Work Hours** - Employees may opt to work a full week (on either the four or five day schedule), but reduce their daily hours worked for all or part of the summer. Employees needn't work reduced hours each day of the week, but may arrange their schedules to work reduced hours on specific days.

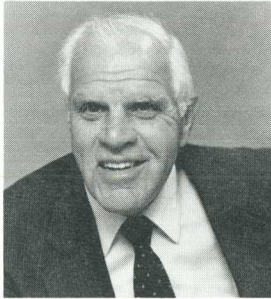

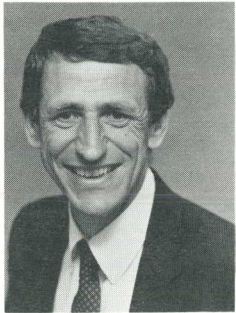


# Potpourri

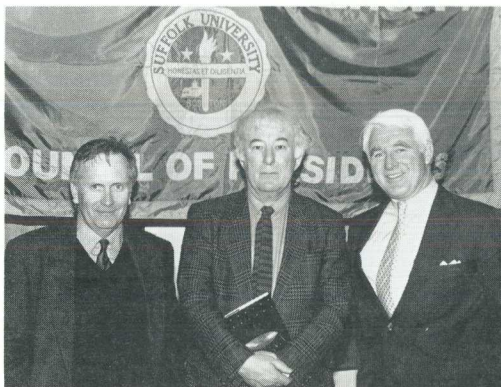
