Degrees Awarded to 1025 Students at May 26 Commencement

A total of 1025 degrees were awarded to students at the May 26 commencement exercises at the Wang Center in a day featuring commencement addresses by Judge Deanell R. Tacha of the U.S. Court of Appeals, 10th Circuit, Lawrence, Kansas and J. Bruce Llewellyn, chairman of the board of the Philadelphia Coca-Cola Bottling Co.

Tacha addressed 469 Law School graduates in morning exercises before Llewellyn gave the address to 556 graduates of the College of Liberal Arts and Sciences and Sawyer School of Management. President David J. Sargent conferred degrees at both exercises.

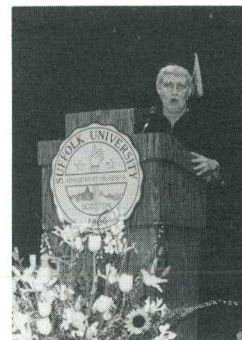
Among those receiving juris doctor degrees was Hung T. Tran of Pembroke, N.H. who in 1983 as a 12-year old escaped from North Vietnam. He was the recipient of the David J. Sargent Fellowship providing him with a three-year scholarship to the law school. Also receiving a

J.D. was Fawzi Musaad Al-Saleh of Cambridge, an engineer and international businessman who is the first Kuwaiti to graduate from a United States law school.

Two graduates overcame serious obstacles to receive degrees. Michael J. McDermott III, a blind student from Cambridge, received an MPA degree and Laurie R. Korajczk of Woburn, returned to Suffolk Law School after a year-long absence where she overcame severe medical difficulties which left her with a heart ailment and impaired vision. She received her juris doctor degree cum laude.

The CLAS/SSOM graduating class included students from 26 foreign countries. The Law School class numbered students

90th Anniversary Kicks Off September 19

Suffolk University turns 90 this year and to mark the momentous occasion, the University will conduct a year-long celebration kicking it off with a gala on Sept. 19. It was on that date in 1906 that Gleason L. Archer conducted the first class of his evening law school in his Roxbury apartment.

According to Vice President Marguerite J. Dennis the opening event will be held at One Beacon Street from 6 p.m. to 10 p.m. and will feature a video debut of Suffolk's history that will be used throughout the year at various events.

The celebration will be entitled "90 Years of Excellence-A Tradition of Opportunity."

"We are planning an evening filled with special guests, exhibits, great food from neighborhood restaurants, music and dancing and much more," said Dennis.

Dennis said the lobby of One Beacon will be transformed into a street-scape of

Beacon Hill and the surrounding area to represent both the old and new Suffolk campus. "The plaza outside the rear of One Beacon will be decorated and will provide an inviting space for people to enjoy our entertainment and other special surprises," Dennis explained.

The opening event will not only kick off the 90th anniversary but also the public phase of the fund-raising campaign. Dennis urged members of the Suffolk community to call Public Affairs at Extension 8447 if they have events they think should be included in the celebration.

"We are inviting all alumni in addition to faculty and staff and expect this to be one of the largest celebrations Suffolk has ever held," Dennis said. She said invitations will be going out in August but asked people to spread the news on this activity that "will truly reflect and showcase the remarkable history and great accomplishments of Suffolk University." *

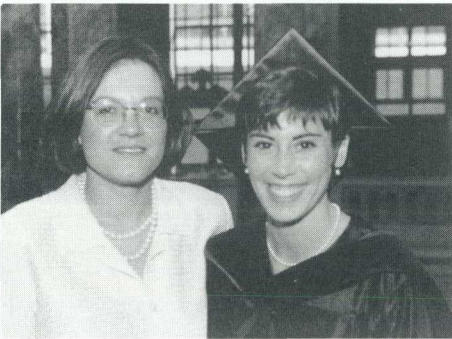

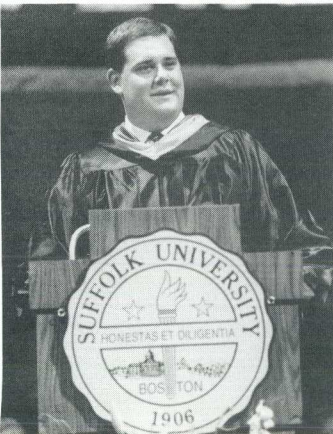

from 172 colleges in 23 states. Fifty-four percent of the Law School graduates were women.

The MBA graduating class featured a husband and wife team, Christos and Julie T. Kuliopulos of Reading.

In his address to the afternoon group, Llewellyn said that graduates will be entering a society divided over the distribution of wealth, medical care, education and racial issues. "What are your prospects, everybody's prospects today?" he asked. "My answer is in two words, pretty lousy."

A member of the President's Advisory Committee for Trade Policy and Negotiations, he told the students they can have successful careers while also doing good deeds.

Judge Tacha, who is presently chair of the

Judicial Administration Division of the American Bar Association, has served as a Federal jurist since 1985. Suffolk President Sargent cited her as "a shining example of a career spent in service to one's profession, one's ideals and one's country."

Judge Tacha received the honorary degree of doctor of laws. Llewellyn was awarded an honorary doctor of commercial science at the afternoon exercises. In his citation, Sargent termed Llewellyn's entrepreneurial origins "truly inspiring."

Other honorary degree recipients were (Law School) Judge Joyce London Alexander, magistrate judge, U.S. District Court in Boston; Associate Justice Charles Fried of the Massachusetts Supreme Judicial Court; and Judge Robert A. Mulligan, chief justice of the Massachusetts Superior Court; (Colleges) Robert L. Caret, president of San Jose State University in California, a 1969 graduate of

Suffolk's College of Liberal Arts and Sciences, doctor of humane letters; Victor K. Fung, chairman of Prudential Asia Investments Limited in Hong Kong, doctor of commercial science; and Donald Rodman, president and CEO of Rodman Ford and Rodman Lincoln-Mercury, doctor of commercial science, and A. Neil Pappalardo, president and CEO for Meditech in Boston, doctor of science.

Student speakers were Stacey G. Harris of Somerville, for the Law School, and Russell C. Patten of Quincy, for CLAS/SSOM.

Suffolk University has a new food service company.

Sodexo with corporate offices in Waltham began managing all of the University's food operations May 20 replacing ARAMARK's Business Dining Services.

Suffolk Business Manager Paul Ryan said it is expected that both the Sawyer and Donahue cafeterias will sport new looks by summer's end, but there will be a lot of familiar faces working for the new vendor. Approximately two thirds of the existing staff will be retained.

Sodexo presently operates the cafeteria at One Beacon Street. It is an international company whose USA headquarters is in Waltham. The new manager will be Lauren Patterson, who can be reached at Extension 8458.

"In addition to operating the Sawyer and Donahue sites, they are also helping us design and will operate the dining facility in the new residence hall at 150 Tremont St., Ryan said. *

Ortwein, a member of the law faculty since 1974, will work with Associate Dean William T. Corbett on academic matters.

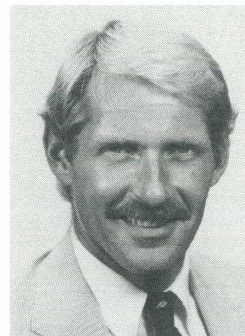
"I have great respect for Professor Ortwein and I am sure he will make a significant contribution to the Law School,"

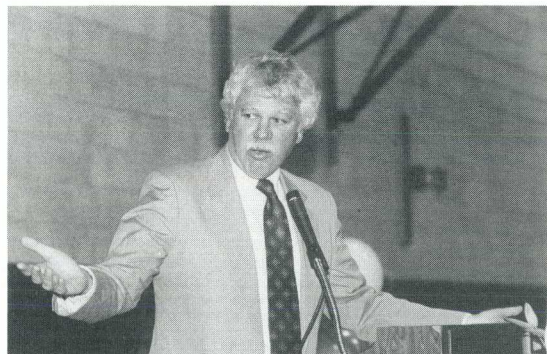
Brown and Mrs. Law accepted achievement awards from Athletic Director Jim Nelson.

Nick Papas, a retired teacher in Watertown, covered the forties, George Doucet, a Revere teacher, recalled the fifties, Ron Cinelli, baseballer and hoopster, now a salesman, spoke of the sixties, Atty. On Retirement — Asset Allocation

As we begin to think about our retirement savings and the need to adequately fund our own retirements, we often begin to ask, "Am I saving enough? Is it possible for me to save more each year?"

Suffolk University's Standard Retirement Plan requires a contribution by you of 5 per cent of your gross compensation for a University contribution of 9 per cent. While 14 per cent of your salary is a good start on retirement savings, for many of us it isn't enough. The University offers an option for tax-deferred retirement saving for employees who either wish to contribute more than the Standard Plan's requirement or who aren't eligible for participation in the Standard Retirement Plan (because they are younger than 26, are employed in an ineligible class such as the adjunct faculty or have worked less than 1000 hours in the past year at Suffolk and/or another institution of higher education). That option is called the Voluntary Tax Deferred Annuity Plan.

Because contributions under both the Standard Retirement Plan and the Voluntary Tax Deferred Annuity Plan are tax deferred, the IRS strictly limits our annual allowable contribution. The amount an individual may contribute to both plans each year is called the Maximum Exclusion Allowance. This number is specific to each of us and may well vary for each of us from year to year.

The calculation of your Maximum Exclusion Allowance requires reference to several sections of the Internal Revenue Code. Section 403B limits contributions based on your salary, years of service at Suffolk and prior contributions to the plan by you or Suffolk. Section 415 limits contributions to the lesser of 20 per cent of your salary minus 80 per cent of Suffolk's contribution on your behalf of \$30,000. Section 402G limits contributions generally to \$9500 a year (although employees with 15 years of service to Suffolk may be able to contribute up to

\$12,500 a year with certain restrictions). Your Maximum Exclusion Allowance for the year is the least of these three figures.

We, as employees of an educational organization, also have available to us several "alternatives" to the calculations described above. In some instances, these alternatives may allow a greater contribution than the "General Limit" above. However, only one alternative may be elected over an individual's working life. Alternative B tends to be best for employees with several years of service who have not contributed up to their maximum tax deferral limit in the past, while Alternative C tends to be best for new employees who wish to fully maximize contributions early in their careers at Suffolk.

A Reminder on Health Insurance

Summer's here but it won't be long before Fall is upon us. With that in mind, remember if you have a child age 19 or older who will not be returning to school full-time next year, come Fall that child will no longer be eligible for health insurance coverage under your family plan.

Dental coverage for your child will end at age 19 regardless of your offspring's student status. Please contact the Human Resources Office to discuss health and/or dental insurance options for your child.

If he or she will be a full-time student next year, the Human Resources Office will need a letter from the school's registrar verifying that full-time status. This letter is required even if you provided one last year.

Of course, if your children are younger that you may have other concerns. If you would like some assistance in identifying

day camps or specialized summer programs for them, consider calling WarmLines at 617-244-6843. WarmLines is the resource and referral services for Suffolk University employees' child and elder care needs. There is no cost for this service.

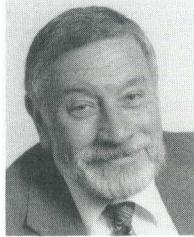

McKenzie succeeds Michael J. Slinger, who left the Suffolk post to become director of the Law Library at Cleveland-Marshall Law School a year ago.

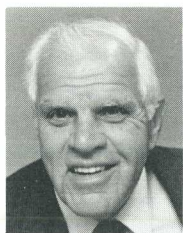

SSOM Opens MPA Program on Cape Cod

Suffolk University's Sawyer School of Management is opening a Master in Public Administration program on Cape Cod beginning in September.

David Pfeiffer, chair of the Public Management Department, said the program, to be held on Saturdays, will be held at Cape Cod Community College on Route 3 in Barnstable.

"Our Cape Cod program offers area residents and weekend vacationers alike the opportunity to take advantage of the MPA program," Pfeiffer reported. "The Cape Cod Community College campus offers students a full range of services, resources and tools for academic success and reward.

The 10-week semesters, beginning in September, January and April, offer two different courses- 8:30a.m. to 12 noon and 1p.m. to 4:30p.m. Cape Cod campus students will be able to complete eight courses per year and be able to complete their full MPA program in two years.

The program will include concentrations in disability studies, health administration, finance and human resources administration, nonprofit administration and state/local government administration.

The courses will be taught by Suffolk Full-time MPA faculty. *
